What is Systemic Racism?

- Racism resulting from the inherent biases and prejudices of the policies and practices of social and political organizations, groups, or institutions.

PROGRESS:

The elimination of some institutionalized racism

- slavery
- Jim Crow Laws
- Prohibitions on voting & owning land
- Separate but equal schools

CURRENT DISPARITIES btwn

Whites and Minorities:

- Unemployment
- Median wealth
- Home Ownership
- Criminal Justice System
- Voting
- Education

Racism and Economic Inequality

Median wealth for white households:

- **ten times greater** than for black households
- **eight times greater** than for Hispanic households.

Native Americans, African Americans, and Hispanics:

- experience poverty at roughly **twice or more than twice** the rate of whites.

Racism and Education

Minority Students Have Limited Access to Quality Education.

- ❑ Segregated schools
- ❑ Underfunded - local real estate
- ❑ Limited access to rigorous coursework
- ❑ Teachers in urban schools tend to be the least experienced
- ❑ Limited access to Early Childhood Education

Currently the demographics of students obtaining a college degree in 4-6 years:

- 62% of white students
- 45% of Latino students
- 38% of Black students
- 13% of Native Americans

Racism and Employment

- The Equal Employment Opportunity Commission was created to protect against illegal discrimination in the workplace.
- Yet, in 2016 the EEOC was investigating tens of thousands of racial discrimination cases.
- In the first quarter of 2018, unemployment rates were:
 - African American - 7.2%
 - Hispanic - 5.1%
 - Asian - 3.0%

Racism and Housing

U.S. Federal Housing Administration created policies in the 1950s and 1960s- **REDLINING** practice - Banks could not receive federal insurance for loans made inside these predominantly black neighborhoods.

Even with the Fair Housing Act of 1968, which was to end housing discrimination, ending segregated housing has not resulted.

Health Care Inequities

Cultural competency is necessary for a successful healthcare visit:

- providing language interpretation
- providing verbal instructions for a patient who lacks English literacy skills.

Because people of color are more likely to be employed in low-wage jobs that do not offer health coverage, they are more likely to be uninsured than white people.

Racism and Criminal Justice System

Over the past 4 decades = 500% increase in # of people incarcerated in the United States

U.S. has 5% of the world's population, but roughly has 25% of the world's prisoners

African Americans and Latinos = 56% of the U.S. prisoners and only 28% of the U.S. population.

USCCB advocates for sentencing reform:

- Increase in rehab & restorative programs
- Focus on education
- Focus on literacy
- Job-placement
- Substance Abuse Treatment

Racism and Voting

Poll taxes and literacy tests became a part of the election process.

Gerrymandering (redrawing of voting district boundaries) were used to suppress the African American vote.

Even with the Voting Rights Act of 1965, we still see many barriers to voting for People of Color:

- Photo ID Voter laws
- Voting rights of prisoners
- Restrictions on early voting
- Lack of polling & registration sites
